(i) Tenderer should have satisfactorily completed (# Phase/Part completion of the scope of work in a contract shall not be considered, however pre- determined phasing of the work will be accepted) three works, each of Rs. 9,24,303/- (excluding GST) or two works, each of Rs. 11,55,378/- (excluding GST) or one work of Rs. 18,48,606/- (excluding GST) in single contract of similar nature of Electrical spare supply work during last seven years ending on 28.02.2023.

The details of similar works completed during last seven years in the given format Form-A with supporting documents issued by client.

<u>Note</u>:

- 1. The Experience Certificate of works completed pre-GST era, Completion amount will be divided by 1.12 (to exclude pre-GST taxes) to make it at par with experience certificates of post GST era but excluding GST.
- 2. The Tenderers invited for Annual Rate Contracts for O&M/ AMC/ CMC works, the works experience may be counted for the value of work for a completed one year

on pro-rata basis to prequalify agency that has completed one year of AMC but work is still not completed due to longer period of AMC.

- 3. Experience gained by executing work on back-to-back contract/ Sub-contract basis is acceptable in the following conditions:
- (a) Work should be actually executed by the second agency (sub-contractor) with due concurrence of the owner as tripartite agreement/ written approval. It should be backed by valid agreement and experience certificate.
- (b) Payments received by second agency should be reflected in TDS certificates.
- 4. Experience gained in composite works for the specialized nature of works were executed by main contractor either by in-house expertise & experience or by engaging the specialized agencies with the approval of main client as per contract conditions. In such cases, main contractor as well as specialized agency both get the experience certificate for the same work from their respective client (s) i.e. main contractor for composite work along with specialized works from owner and specialized agencies for specialized work(s) from the main contractor.

In this situation, the experience certificate of either specialized agency or main agency having in-house expertise & experience, who has actually executed the specialized work(s), shall be considered for Technical, Pre-qualifying criteria in similar specialized nature of work(s).

"The value of executed works and consultancy (design/drawing) shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion up to previous day of last day of submission of bids."

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. **Tenderers showing work experience certificate from non-government/ non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work.**

(ii) Tenderer should have average annual financial turnover of **Rs. 6,93,227/-** on construction works during last three years ending **31.03.2022.** The Financial

Information shall be submitted in the given format - Form-B i.e. Annexure-6 at page 20 of Tender Document.

Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.

- (iii) The tenderer should have a minimum net worth of Rs. 3,46,614/- issued by certified Chartered Accountants. The Certificate should be submitted in the given format Form C i.e. Annexure-7 at page 21 of Tender Document.
- (iv) Tenderers must have to submit only UDIN generated Financial documents like Balance Sheet/Turnover certificate, Working Capital Certificate (works done during last 5 financial years & works in hand), Net worth Certificate, Tax Deduction at Source (TDS) Certificates for Non- Govt. works etc. as per NIT conditions duly certified by CA and having UDIN. The documents submitted by bidders without UDIN shall not be entertained and without submission of UDIN documents the bid will be summarily rejected.

Scanned copy of all the Documents of Envelope-I mentioned above shall be submitted on the CPP portal. The tenderer, whose Insurance Surety Bond/ BG against EMD if submitted offline are not received by the date & time mentioned in critical data sheet, then their tenders will be liable to be rejected. Envelope-II: - The Financial e-Bid through CPP Portal.

All rates shall be quoted in the standard BOQ format provided with the tender and no other format is acceptable. Tenderers are required to download the standard BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected.

3. Refund of EMD

EMD amount of the rejected/ unsuccessful bidders will be returned to their source account after submission of Technical/ Financial evaluation report on CPP portal by bid manager. If EMD submitted in the form of BG shall be returned by post.

4. Bid Submission

The CPP tenderer shall submit their bid only Portal: at https://etenders.gov.in/eprocure/app. Tenderer/Contractor are advised to follow the instructions provided in the tender document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents required as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of bid in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

- 5. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- **6.** Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website https://etenders.gov.in/eprocure/app., shall not tamper/ modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/ modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with IAA.

7. Bids Opening Process:

Envelope-I (Tender Processing Fee, EMD, Technical bid and Pre- qualification):

Envelope-I containing documents as per Para 2 (A) & (B) (uploaded by the tenderers) shall be opened on date & time mentioned in **CRITICAL DATA SHEET**.

If the bidder has any query related to the Bid Document of the work, they should use 'Seek Clarification' on CPP portal to seek clarifications. No other means of communication in this regard shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope - I, he will be asked to provide it through CPP portal, if required. The tenderer shall upload the requisite clarification/ documents within time specified by IAA, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/rejection of their bids will be intimated to the tenderers through CPP portal.

Envelope-II (Financial Bid):

Envelope-II containing financial bid of the tenderers found to be meeting the technical criteria and qualifying requirements shall be opened on date & time mentioned in CRITICAL DATA SHEET. (In case the date and time for opening of Envelope-II {Financial bid} is required to be changed, the same shall be intimated through CPP Portal).

- **8.** IAA reserves the right to accept or reject any or all applications without assigning any reasons. IAA also reserves the right to call off tender process at any stage without assigning any reason.
- **9.** IAA reserves the right to disallow the working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/ Temporary or Permanent debarment/ black listing by any department of IAA or Central/ State Govt. Depts./ PSUs/ World Bank/ ADB etc. **IAA reserves the right to verify the credential submitted by the tenderer at any stage (before or after the award of work). If at any stage, any information/ documents submitted by the applicant is found to be incorrect/ false or have some discrepancy which disqualifies the tenderer then IAA shall take the following action:**
- (a) Forfeit the entire amount of EMD submitted by the tenderer.
- (b) The Tenderer shall be liable for debarment from tendering in IAA, including termination of the contract apart from any other appropriate contractual/legal action.
- **10.** Consortium / JV companies shall not be permitted.
- **11.** Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.

12. Concessions to Indian Micro & Small Enterprises (MSEs) Units: -

As per the provisions of public Procurement Policy for MSE's Order 2012, MSEs (Micro & Small Enterprises) registered with MSME/DIC/NSIC/KVIC/KVIB/Directorate of Handicraft and Handloom etc. Only following concessions shall be applicable and extended to the MSEs of same specifications under which they are register equaling tender scope of work.

- i) **Tender Document Fee/EMD Fee:** MSEs Bidders seeking exemption and benefits on tender fee/ EMD fee should submit signed self-attested scanned copy of valid MSE Registration Certificate, giving details of such validity and scope of work covered etc. in Envelope-I (Fee), failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs. The benefits to MSEs shall be available only for the goods/Services produced and provided by MSEs for which they are registered.
- ii) For this tender MSEs Bidders seeking exemption for tender fee/EMD fee they must submit the MSMEs certificate which clearly mention that the certificate is issued for the <u>"work of Supply of E&M Spares/Supply of technical Spares or tools/E&M</u> <u>rectification works/E&M AMC works, if it was found that the certificate is not</u> <u>issued for these works it will be presumed that the bid is submitted without</u> <u>tender fee and the bid of the agency shall be summarily rejected.</u>
- iii) a) Exemption for EMD & tender fee will be given only to those bidders who are found eligible (eligibility as mentioned below in NIT clause 12 i & ii.

(b) Implementation of micro, small and medium enterprises development (MSMED) Act, 2006.

It has been clarified that benefit to MSMEs shall not be extended to construction work as it cannot be treated as service rendered or supply of goods.

It is further clarification that capital MEP work like Electrical & Mechanical (E&M), HVAC, BHS, Power supply system, fire alarm & detection and PA system etc., which involve SITC, also fall under the category of construction work and hence the benefits to MSME shall not be extended for these works.

Supply of material/ goods and services like supply of manpower, where consumable material is involved can be considered for the benefits to the MSME as per public Procurements policy.

Further, it is also clarified that benefits to MSME shall be available only for the goods/ services produced and provided by MSME for which they are registered as mentioned clearly in their MSME/ NSIC certificate.
